# APPROPRIATION ORDINANCE 2017. 🗸 8

BE IT ENACTED BY THE QUORUM COURT OF COLUMBIA COUNTY, ARKANSAS:

AN APPROPRIATION ORDINANCE TO BE ENTITLED: AN ORDINANCE APPROPRIATING THE ANNUAL OPERATING BUDGET FOR COLUMBIA COUNTY FOR THE CALENDAR YEAR 2018.

for ANNUAL BUDGET ADOPTED BY REFERENCE. The annual budget SECTION I calendar year 2018 identified as "2018 Annual Budget, Columbia County, Arkansas", which budget was approved by the Quorum Court at its meeting on November 13, 2017; is hereby adopted by reference. A copy of said budget shall be filed in the Office of the County Clerk and shall be available for public inspection and copying by any person during normal business hours.

SECTION 2 NON-RESTRICTED EXPENDITURE CATEGORIES. Expenditure of funds appropriated by this Ordinance shall not be restricted to the line item expenditure codes comprising the four major categories of expenditures-Personal Services, Supplies, Other Services and Charges, and Capital Outlaybut shall be restricted to office/departmental expenditures within the above enumerated four major categories of expenditures, except for funds appropriated for personnel salaries and wages and related employee benefits. Personnel expenditures shall not exceed the dollar amounts, number of employees, and salary or wage rates specified in the annual budget or an amendment thereto.

EXPENDITURES RESTRICTED TO SPECIFIED FUND. No expenditure of **SECTION 3** appropriated funds shall be made from any fund other than the fund specified in this Ordinance or an amendment thereto.

TRANSFERS. Any transfers of monies between the various funds of the County or **SECTION 4** between the four major categories of expenditures-Personal Services, Supplies, Other Services and Charges, and Capital Outlay-shall be made only with prior approval of the Columbia County Quorum Court. Provided, however, all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.
